We consider this publication — along with our guides, slide decks, and other support materials — as a type of OER that informs faculty, staff, and students during their production or usage of open textbooks or other open educational resources.

What is the Awards for Excellence in Open Education?

The Awards for Excellence in Open Education recognizes outstanding contributions to the open education movement in British Columbia. These contributions may include significant leadership, OER development, research, or advocacy by faculty, students, support staff, or administrators at post-secondary institutions in B.C. or others that support the post-secondary system in B.C. Individuals or teams may be recognized.

Anyone may propose a nomination, but individuals may not self-nominate. Individual award nominations are made in writing via the online form. The open education team at BCcampus adjudicates the award each month. Award winners receive a certificate of recognition and are profiled on the BCcampus website.

Note: There is no deadline for nominations as one award is granted each month.

What is the BCcampus Open Education Faculty Fellows Program?

The Faculty Fellows program was started in 2015. The program was designed to encourage adoption of existing open textbooks, advocate for, and educate faculty about, the adaptation and creation of open textbooks, and ensure the continuing quality and relevancy of the B.C. Open Textbook Collection.

The Open Textbook Summit is typically scheduled in late May or early June, and occurs every two years during odd-numbered years, e.g. 2017, 2019, 2021.

For 2019, the Cascadia Open Education Summit will replace the Open Textbook Summit.

During alternate, even-numbered years, the Open Education stream of the Festival of Learning takes the place of the Open Textbook Summit.

In addition to reducing costs for students through open textbooks, BCcampus Open Education facilitates an improved learning environment for instructors and students by encouraging open textbook authors to follow Universal Design for Learning (UDL) principles to improve accessibility for all students. It is the goal of BCcampus to ensure that as many books as possible in the B.C. Open Textbook Collection are accessible. These books are tagged with an “Accessible” flag and fulfill the requirements noted on the Checklist for Accessibility.

What does accessibility refer to?

Accessibility refers to the access of—or ability to obtain—the information in an open textbook by students, instructors, and others.

Textbooks in the B.C. Open Textbook Collection that meet BCcampus accessibility standards are marked with an Accessible flag. The required accessibility criteria address:

- content organization
- images
- links
- tables
- multimedia
- formulas
- font size

What does adaptation mean?

Adaptation is a term frequently used in the open education field that refers to making changes or revisions to open textbooks or other open educational resources. These changes are permitted, without contacting the author, because of the open-copyright licence with which the resource is released.

How do I adapt an open textbook?

To adapt an open textbook from the B.C. Open Textbook Collection, download an editable file of the book (e.g., DOC, EPUB, HTML, ODT, XML) and make changes. Not all open textbooks have editable files available. However, BCcampus Open Education is working on creating as many as possible.

Should adapted B.C. collection books be sent to BCcampus?

Books from the B.C. Open Textbook Collection that have been revised or adapted need not be submitted to BCcampus.

However, if you have revised an open textbook and would like it to be considered for the B.C. Open Textbook Collection, please fill out the Suggestion for the Collection form. A selection committee will examine each submitted textbook to confirm that it meets the minimum requirements.

Does BCcampus keep a list of adaptations of its books?

BCcampus does not keep a list of adaptations because it would be very difficult to track all of the many revisions and customizations created from the books in the B.C. Open Textbook Collection.

However, instructors are encouraged to make changes to any openly-licensed textbook—from the B.C. collection or elsewhere—for their classroom.

Are books in the B.C. collection always changing?

No. Just because users have the ability—physically and legally—to change an open textbook, it was decided at the beginning of this project that all books in the B.C. Open Textbook Collection would remain static. They can be changed by anyone, but the copies in the collection are not affected by these changes.

If an updated version or edition of a textbook is added to the collection, this is clearly marked on the book's cover

During the process of updating a book, both versions of the book remain in the collection until instructors have had time to adjust the textbook requirements for a course. BCcampus OpenEd takes all steps possible to inform the education community about an upcoming change to a book in the collection, prior to the change.

What does adoption mean?

In open education, adoption refers to the use of an open textbook or other open educational resource in the classroom.

For adoption tracking purposes, BCcampus Open Education defines adoption as follows: “Each adoption refers to a course section within a specific term and year for which an open textbook has replaced a primary textbook or educational resource that must be purchased.” See Open Textbook Stats for more information.

If you’re an instructor at a post-secondary institution in British Columbia, please fill out the BCcampus Open Education Adoption Form so we may track usage in this province.

May anyone use books from the B.C. collection?

Yes, anyone in the world — instructor, student, or other — is permitted to use all items in our collection.

Because these textbooks are openly licensed, anyone may make changes to the textbook as long as the original author is given credit. For example, instructors can make changes to these books to fit what is needed in the classroom.

Must I register to use an open textbook?

No, there is no need to fill out an application, create an account, or register to use a book from the B.C. Open Textbook Collection, and gain approval. Anyone is permitted to use and/or download open textbooks in the B.C. Open Textbook Collection.

Must I inform the author if using their open textbook?

You are not required to inform anyone—author or publisher—if, or how, you’re using an open textbook. The open-copyright licence with which an open textbook is released states that you are free to reuse, retain, and redistribute it as you wish (as well as revise and remix it).

However, if you’re an instructor with a post-secondary institution in British Columbia, please fill out the BCcampus Open Education Adoption Form so that we may track statistics on usage in this province.

Does an open textbook affect a course's transferability?

According to the BC Council on Admissions & Transfer (BCCAT), articulation and course transferability should not hinge on the use of specific textbooks in a course.

Articulation is based on equivalency of content, skills, learning outcomes, topics, and competencies even though instructors may choose to use a textbook that covers the full range of learning outcomes of a course.

The guides, *How to Articulate*, *The Sender's Guide* and *The Receiver's Guide* (<http://www.bccat.ca/articulation>), discuss the parameters for articulation, but none mentions textbooks as an element in the decision-making process.

Is there a risk I will lose access to an open textbook mid term?

The open textbooks in the B.C. Open Textbook Collection are controlled by our project, not individual authors or outside publishers, so access will not be restricted unexpectedly. On occasion, we will archive a textbook in the collection. Before this happens, however, we are sure to take the following measures:

1. Inform other projects that access and use our collection as part of their own
2. Inform any adopting faculty who have reported to us that they have adopted this textbook
3. Place a notification in the BCcampus newsletter published weekly

An ancillary resource is supplemental material that can be used with an open textbook, such as a bank of test questions and answers, videos, or sample exams.

Textbooks that include one or more ancillary resources in the B.C. Open Textbook Collection are marked with an Ancillary Resources flag.

Why are open textbook test banks restricted to instructors?

Test banks are restricted to instructors only, in B.C. and elsewhere in the world, so that they can be used for testing purposes. Thus, we ask that faculty who receive these ancillary resources do not post them publicly or share them with students.

The BCcampus Open Education Support team vets each instructor request for test banks before sharing these resources.

What does OER stand for?

OER stands for open educational resources and refers to educational resources, such as textbooks, readings, multi-media files such as videos and audio clips, assessment tools like exams and test banks, online courses, syllabi and lesson plans, and even software, that are openly licensed. The open copyright licence ensures that the OER are freely accessible, typically free to use, and that users are free to make changes.

What is an open textbook?

An open textbook is a textbook released with an open-copyright licence and made available online and in a variety of file types to be freely used by students, teachers, and members of the public.

Is an open textbook an ebook?

An open textbook is often available digitally either as an ebook or online. However, an ebook is not necessarily an open textbook. The identifying feature of an open textbook is the open-copyright licence with which it is released. Sometimes an open textbook is part of the public domain because its copyright has expired or it has been delegated to the public domain by its creator.

Who funds the creation and maintenance of open textbooks?

BCcampus Open Education, responsible for the B.C. Open Textbook Collection, is a publicly funded project that receives funding from the B.C. Ministry of Advanced Education, Skills & Training and the Hewlett Foundation.

May an open textbook be sold?

Yes, an open textbook may be sold. There are no restrictions on charging for an open textbook or other OER unless NC (NonCommercial) is part of its licence. And even then, it is permissible and standard practice to charge for cost recovery (printed costs of the book + basic overhead).

How can I submit my textbook to the B.C. collection?

To submit a textbook to be considered for the B.C. Open Textbook Collection, please complete the Suggestion for the Collection form. A selection committee will evaluate each submitted textbook to confirm that it meets the minimum requirements.

If a book is not chosen, it will be added to the *OER by Discipline Directory*. The BCcampus Open Education team informs the open education community at large about updates to this directory via the BCcampus newsletter and mailing lists. If the textbook is authored by a B.C. post-secondary instructor, staff, or student, it will be listed in the *Post-Secondary Directory*.

How is the B.C. Open Textbook Collection maintained?

The B.C. Open Textbook Collection is maintained by the Coordinator of Collection Quality of BCcampus Open Education including:

- regular review and upgrade of the collection and its books
- evaluation of new open textbooks available from other sources, from recommendations submitted through the Suggestion for the Collection form, from OER created with funding from BCcampus Open Education grants
- responding to submissions from the Report a Textbook Error form

In the B.C. collection, what does the date beside each title indicate?

The date beside each book title indicates the last time the textbook was updated in the B.C. Open Textbook Collection.

An update is usually a minor, backend adjustment that does not affect its content. When content is changed, this adjustment is noted on the **Versioning History** document listed on the textbook's record page in the B.C. Open Textbook Collection. (We are in the process of posting **Versioning History** documents for each book in this collection.)

When a significant amount of content is modified, the new textbook files and web version are posted alongside the older files; a removal date (typically one month or more after the start of the next term) is noted by the older files.

How does BCcampus assign ISBNs to open textbooks?

BCcampus assigns both print and ebook ISBNs to open textbooks published by BCcampus and accepted to the B.C. Open Textbook Collection. For other open textbooks, the author is responsible for obtaining an ISBN.

How should textbook errors be reported?

If you find an error in an open textbook, please fill out the Report a Textbook Error form. We will inform the author of the error and make the required corrections. Once that is done, the changes will be noted in the book's "Versioning History" page and all files will be replaced.

Are MARC records available for the B.C. Open Textbook Collection?

The MARC record set for books in the B.C. Open Textbook Collection was created according to a standard accepted by the BCLA Cataloguing and Technical Services Interest Group (BCCATS). The cataloguing closely conforms to the Provider Neutral Record Standard (PDF). Cataloguers at Vancouver Island University and Kwantlen Polytechnic University were directly involved with the creation of the records.

What is an open licence?

An open licence, or open-copyright licence, grants permission to access, retain, reuse, redistribute, and build upon (remix and revise) a work with few or no restrictions.

What is a Creative Commons licence?

A Creative Commons (CC) licence is a type of open-copyright licence that enables authors to release their work so that users have the right to retain, reuse, redistribute, and build upon (remix and revise) a work that they have created.

May I make copies of an open textbook?

Yes. The Creative Commons (open) licence on an open textbook gives anyone permission to make copies of all or part of it. These copies may be kept (retained) or distributed.

May I use an image or text from an open textbook without permission?

The short answer is yes.

By definition, an open textbook is a book for which an open-copyright licence has been applied. This means that anyone is allowed to use, keep, share, and change the information within that work, without asking the author's permission, provided the author is given credit in an attribution statement.

If using a specific image within a textbook, check the caption of the image and any attribution statements at the bottom of the web page for additional licensing conditions that may apply. Images within a textbook are sometimes covered by a different Creative Commons licence than the textbook in which they are used.

May I link to or embed restricted material in my open textbook?

May a fee be charged for a book with a NC (NonCommercial) licence?

It's acceptable to charge for cost recovery (which could include cost of printing + basic overhead), but bookstores cannot make a profit on the sale of an NC-licensed work. Think of it like this: What does the bookstore need to charge to break even—and not make a profit—when it sells a printed copy of the NC-licensed textbook? Those charges would be acceptable.

Cost recovery (printing cost of the book + basic overhead) is widely accepted as allowable with NC-licensed content.

What is the public domain?

The public domain refers to material for which no copyright exists. In most instances, copyright for these items has expired. However, there are several cases where the author or creator has decided to release their work into the public domain by waiving all copy and related rights. For this, a CC0, “no rights reserved”, logo is often used.

What is the difference between intellectual property and copyright?

Copyright is one type of intellectual property and in Canada (copyright laws vary by country) specifically covers “all original literary, dramatic, musical and artistic works provided the conditions set out in the *Copyright Act* have been met.”

Intellectual property (IP) refers to “creations of the mind” such as copyrighted works, patents, trademarks, industrial design, and geographical indication.

Creative Commons (CC) licences “do *not* license rights other than copyright and similar rights...For example, they do not license trademark or patent rights...” The other name for a CC licence is open-copyright licence.

- The author must send you a link to the book.
